Northern Pines is excited to announce the return of the Northern Pines Worship Band to camp in 2012! If you are interested in the application process, please take a look at the following guidelines.

1. Application to be a part of the NP worship band is open to any NP alumni.
2. Priority is given to alumni who:
 - a. have previously served on the NP worship band.
 - b. are serving as counselors in another area of NP camp staff during the week(s) of camp. (Childrens, Wilderness, Jr. Hi, Sr. Hi, Young Adult, CCA)
 - c. are available for both weeks of camp – this is not a requirement, but is preferred.
3. The NP worship band is not a compensated position. If the alumni are not serving in another area of camp ministry, a \$100 worship band scholarship is available towards camp registration cost.
4. A pre-camp rehearsal may be required in Minneapolis the Thursday and Friday prior to the first week of camp. We will work with all participants to help with housing.
